- (a) <u>Apologies for absence</u> There were no apologies for absence, however, it was noted that Cllr Charlton had informed that he would not be able to make the start of the meeting.

(a) The following planning applications were considered:-

APPLICATION REF: 24/504619/FULL PROPOSAL: Section 73 Application for Variation of Condition 2 (to allow a new location and layout) and removal of Condition 5 (soft landscaping) pursuant to 22/502396/FULL for Creation of a sand school horse training area for private use. ADDRESS: Hillcroft Ulcombe Hill Ulcombe Kent ME17 1DJ. It was RESOLVED to approve this application but for it not to be taken to committee if contrary to the officer's decision.

APPLICATION REF: 24/504642/FULL PROPOSAL: Retrospective application for the erection of a small timber stables and creation of a gravelled footpath. ADDRESS: Apple Trees Ulcombe Hill Ulcombe Kent ME17 1DJ. It was RESOLVED to approve this application but for it not to be taken to committee if contrary to the officer's decision.

(b) The following planning appeal was received.

Proposal: Change of use of agricultural field to an 8no. pitch glamping site comprising 3no. yurts, 4no. safari tents and 1no. shepherds hut, including erection of a farm shop with associated storage, staff welfare facilities/accommodation, and provision of WC/shower facilities for glamping tourists, with associated solar panels, parking, access and infrastructure. Location: Chegworth Mill Farm Chegworth Road Harrietsham. Planning Ref 23/505751/FULL. PINS reference: APP/U2235/W/24/3354805. Comments by 17 December 2024. It was RESOLVED to submit a comment.

(c) The following planning decisions by Maidstone Borough Council were noted:-

APPLICATION REF: 24/503732/FULL PROPOSAL: Demolition of garage with erection of a two storey side and rear extension. ADDRESS: Constance Villa Pye Corner Ulcombe Maidstone Kent ME17 1EF. It was RESOLVED to approve this application. – Withdrawn.

- (d) A draft response to the Maidstone Gypsy, Traveller and Travelling Showpeople Development Plan Document Preferred Approaches (Regulation 18b) was received from the KALC Maidstone Area Committee. It was RESOLVED to support this full and detailed response to the consultation. It was also RESOLVED that the Council's own draft response be submitted.
- (e) An email from Esquire Development was received to arrange a meeting to discuss the production of an Infrastructure Development Plan. It was RESOLVED to arrange a meeting in January 2025.

It was noted that little was known regarding the current usage of the site by residents for dog walking etc. It was felt that the site should be secure to prevent access by motorised vehicles.
