9. <u>Kent Highways</u>-There was no further update available on the Kent Highways Improvement Plan.

It was RESOLVED to contact Kent Highways to clear the vegetation blocking the visibility of the yellow warning sign at the junction of Chegworth Road and the A20 and to enquire whether it could be moved closer to the A20.

10. <u>Flooding</u> – An updated flood mitigation document was received from a local resident. It was RESOLVED to keep this on file. It was felt that the resident should be encouraged to forward this to KCC and developers, Jarvis Homes and Esquire.

11. Play Area/Recreation Ground

- (a) A play area inspection has been carried out by Sovereign and their report is awaited. A visual check by the clerk reported no new issues.
- (b) It was RESOLVED to accept the application for use of the recreation ground for the Summer Event on Saturday, 23 August 2025.
- (c) Part of a quote has been received for the refurbishment of the play area and this was accepted in principle. A further quote is awaited regarding the repair/replacement of the wet pour surfaces. This will be circulated upon receipt for ratification.
- (d) It was RESOLVED to accept a quote for an investigation to be undertaken on the recreation ground drainage. This will help in exploring the way forward to help the football pitches during the winter months.

12. <u>Matters for information, urgent matters at the discretion of the Chairman for</u> noting only or any items for further discussion at the May 2025 meeting.

An annual cultivation licence has been applied for with Kent Highways to allow the planting of bulbs on the traffic island at Eastwood Road and Headcorn Road. There was no charge for this.

The NuVenture bus figures for the month of May have been received. This showed a consistent number of passengers using the service.
